



### Care Worker - Curlew Road Day Care

This is a permanent contract of employment working 15 hours each per week.

Reporting to the Day Centre Manager, the Care Worker is responsible for providing person centred care to people with dementia, addressing their needs and enhancing their quality of life.

To be successful in this role you will need experience of working with people with dementia, older people or people with intellectual disabilities. FETAC level 5 qualification is desirable but not essential.

You will need good communication and organisational skills and be able to work on your own initiative as well as part of a team.

Salary will be commensurate with the care sector, and dependent on relevant experience.

The role holder must strictly adhere to all National Guidelines laid out in QSPD guidance and be always COVID aware. Training in PPE / Infection Control and other relevant areas will be provided by ASI prior.

<b>JOB PURPOSE:</b>
The purpose of the role is to provide to people with dementia care and support that is person centred, addressing their needs to enhance their quality of life.

<p><b>Client Care Provision</b></p> <ul style="list-style-type: none"> <li>• Build trusting relationships with clients and their carers so they feel secure and welcome in the service.</li> <li>• Assist the centre manager of the service in the assessment and updating of care plans for each client.</li> <li>• Carry out care plan activities.</li> <li>• Provision of personal care if needed including help with meals, toileting, bathing etc.</li> <li>• Ensure that observations are reported in a timely manner.</li> <li>• Respect the rights, dignity and confidentiality of all clients.</li> <li>• Identify and develop activities to enhance the quality of care delivered.</li> <li>• Promote teamwork by assisting and supporting other staff in their duties in the centre.</li> </ul>
<p><b>Service Administration</b></p> <ul style="list-style-type: none"> <li>• Adhere to service provision, Health and Safety policies and procedures set out by The Society.</li> <li>• Assist in the maintenance of records.</li> <li>• Assist in promoting a positive and safe environment for both client and staff.</li> <li>• Avail of training opportunities identified by the centre manager.</li> <li>• Partake in staff meetings/team briefings and one to one meetings with the centre manager to contribute to the ongoing development and enhancement of the service.</li> <li>• Ensure the facilities are kept clean and in good condition and that the resources of the centre or client are used correctly.</li> </ul>
