



The HRCI-HRB Joint Funding Scheme 2023/2024

The Alzheimer Society of Ireland is pleased to announce its participation in the Joint Funding Scheme 2023/2024 between the Health Research Board and Health Research Charities Ireland.

Scope of the call

The ASI is committed to supporting Irish dementia research, and we now invite applications that are in line with our mission and vision, and focused on improving outcomes for people living with dementia and/or their families. The research must provide knowledge and/or tangible outputs that can enhance The ASI's ability to support people living with dementia and/or their families.

Projects can be up to two years in duration to a maximum of €240,000 per annum*. Only proposals with the potential to deliver excellent, informative, and impactful research within the timeframe and remit of the grant will be considered for funding. In the case where the two highest-rated proposals require less than €240,000 funding combined, The ASI will endeavour to submit both applications to the HRB with a view to co-funding both.

**HRB guidance notes and the application form refer to a maximum award of €300,000 on any one project of up to 3 years' duration. Please note that for all applications under the HRB/HRCI 2023 scheme made through The Alzheimer Society of Ireland, an upper limit of €240,000 across two years applies.*

Instructions to applicants

Expression of Interest

In order to better streamline the application process for both ASI and for applicants, we ask applicants to complete and submit the Expression of Interest form by **15th September 2023 at 5pm**.

Applicants should not complete the Full HRCI-HRB Application form at this stage. We strongly recommend that applicants review the HRB Guidance notes (including the notes on exclusions).

Following an internal review of all Expression of Interest forms received, shortlisted applicants will be invited to complete the full application form for consideration by International Peer Reviewers.

Review Process

- *Stage 1:* Internal Review of Expression of Interest forms to develop shortlist for full application
- *Stage 2:* International Peer Review and ASI Research Review Committee (including Applicant's Right to Reply)
- *Stage 3:* Highest-ranking proposals submitted for consideration under the HRCI-HRB Joint Funding Scheme.

Notification of invitation to submit full application	23rd October 2023 at 5pm
Full application due if shortlisted	8th December 2023
International Peer Review of Full Applications	11th December - 26th January
Right to reply phase following international peer review	29th January - 9th February 2024
Closing date for final submission to The ASI	13th March 2024
Closing date for submission to HRB	27th March 2024 at 1pm
